## CENTRAL COMMITTEE MINUTES

12/15/2011 – EWEB Building, Eugene

The regular monthly meeting of the Democratic Party of Lane County Central Committee, held in the EWEB Building on Thursday evening, December 15, 2011, was called to order at thirty-six minutes past six P.M., Mr. Davis being in the Chair & noting a quorum, & Mr. Becker present & acting as Secretary.
