

# **DEMOCRATIC PARTY OF LANE COUNTY**

## **Central Committee Minutes**

*5/19/2016 – University Of Oregon, McKennzie Hall, Room 221*

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the University of Oregon on Thursday evening, May 19, 2016, was called to order at seven minutes past seven p.m., Mr. Wig being in the Chair and noting a quorum, and Ms. Swenson Harris present as Secretary.

The agenda was adopted as presented.

The minutes were approved as amended.

The Treasurer's Report was received. The Party had \$5,838.50 in income and \$6,432.18 in expenses during the previous month, with a net loss of \$593.68.

The Budget Committee reported that the Party had \$21,275.86 in income for the year and \$20,994.83 in expenses, with a net gain of \$281.03.

The Campaign Services Committee reported that Mr. Kounovsky was incredibly successful as the Party's May Field Organizer. Mr. Coatsworth reported on ongoing community organizing efforts. The Chair reported that the Campaign Services Committee will hold a meeting in June to determine services for the General Election.

The Community Action Committee reported that the Party will participate in the Creswell 4th of July Parade and will have a booth at

Bohemia Mining Days. The DPLC Chili Cook Off will be held in August.

The Chair reported that there is a vacancy for the position of Fundraising Chair. The Party will hold a Happy Hour event in Cottage Grove after the 4th CD District Nominating Convention.

The Organization Committee reported that a Committee Meeting will be held on the first Thursday of June.

The Subcommittee for PCPs reported the name of three people requesting nomination for the position of Precinct Committee Person: Leah Fischer, who was nominated by Mr. Brule and seconded; Jason Ormsby, who was nominated by Mr. Swanson and seconded; and Nina Sobotka, who was nominated by Mr. Keating and seconded.

The PR Committee reported that button sales have been very successful and that campaigns should send calendar items to the PR Chair for inclusion on the DPLC website.

The SCC Delegation reported that the SCC meeting will be held on August 20 and 21 in Eugene. Ms. Gillpatrick reported on the May 1 SCC Meeting.

The 4th CD Delegation reported that the District Nominating Convention will be held at 11AM, on June 4 in Cottage Grove.
