CENTRAL COMMITTEE MEETING MINUTES

1/20/2011 - LANE COMMUNITY COLLEGE, EUGENE

The regular monthly meeting of the Democratic Party of Lane County Central Committee, held in the Lane Community College Forum on Thursday evening, January 6, 2011, was called to order at forty-three minutes past six P.M., Mr. Davis being in the Chair and noting a quorum, and Mr. Becker present as Secretary.
