

# **DEMOCRATIC PARTY OF LANE COUNTY**

## **Central Committee Minutes**

*3/17/2016 – University Of Oregon, McKennzie Hall, Room 129*

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the University of Oregon on Thursday evening, January 21, 2016, was called to order at thirty nine minutes past seven p.m., Mr. Wig being in the Chair and noting a quorum, and Ms. Swenson Harris present as Secretary.

The agenda was adopted as presented.

The minutes were approved as amended.

The Treasurer's Report was received. The Party had \$3,169.04 in income and \$6,858.63 in expenses during the previous month, with a net loss of \$3,689.59.

The Budget Committee reported that the Party had \$15,437.36 in income for the year and \$14,562.65 in expenses, with a net gain of \$874.71.

The Campaign Services Committee reported that Mr. Kounovsky has been hired to serve as the Party's Field Organizer. Mr. Coatsworth reported on ongoing community organizing efforts.

The Community Action Committee reported that the Party will be holding an election night watch party on May 17. Ms. Heermance reported on the Party's booth at the Lane County Fair.

The Chair reported that Mr. Cronin has resigned as Fundraising Chair.

The Organization Committee reported that those who did not file to run as Precinct Committee People will need to run write in campaigns to be elected.

The PR Committee reported that button sales have been very successful and that campaigns should send calendar items to the PR Chair for inclusion on the DPLC website.

The Chair reported that Mr. Wilde has been appointed Rules Chair.

The SCC Delegation reported that the SCC meeting will be held on May 1 in John Day. The Chair reported that Lane County will host the SCC 3rd Quarter meeting.

The Platform Committee moved to endorse Measure 20-239. The measure was endorsed unanimously.

The Central Committee considered the endorsement of two candidates for District Attorney. Mr. Rempel moved to suspend Rule A1 of the Standing Rules to allow consideration of the endorsement of Clayton Tullos. The motion was seconded by Ms. Reilly and failed. Mr. Rempel moved to consider the endorsement of District Attorney Perlow by

voice vote. The motion was seconded by Mr. Pinger and passed. Mr. Coatsworth moved to endorse District Attorney Perlow. Mr. Rempel seconded and the motion passed.

Upon unanimous consent, the Chair adjourned the meeting at thirty eight minutes past eight o'clock.
