Central Committee Minutes

6/16/2016 – University Of Oregon, Lokey Education Complex, Room 1176

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the University of Oregon on Thursday evening, June 16, 2016, was called to order at thirty four minutes past seven p.m., Mr. Wig being in the Chair and noting a quorum, and Mr. Kounovsky present as Secretary.

The agenda was adopted as presented.

The minutes were approved as amended.

The Treasurer's Report was received. The Party had \$5,327 in income and \$9915 in expenses during the previous month, with a net loss of \$4,588.

The Budget Committee reported that the Party had \$26,603 in income for the year and \$30,910 in expenses, with a net loss of \$4,307.

The Campaign Services Committee reported that the committee met to discuss campaign expenses and the endorsement of city council candidates.

The Community Action Committee reported that the Party will participate in the Creswell 4th of July Parade and will have a booth at Bohemia Mining Days, the Whitaker Block Party, and Eugene Springfield Pride.

The Chair reported that Tom Nelson has been appointed Fundraising Chair.

The Organization Committee welcomed new PCPs. A Precinct Committee Person training will be held in place of the August Central Committee Meeting.

The Subcommittee for PCPs reported the names of nine people requesting nomination for the position of Precinct Committee Person: Adam Fishman, who was nominated by Mr. Wig and seconded; Mel Barber, who was nominated by Mr. Foster and seconded; Nicholas Engel, who was nominated by Mr. Foster and seconded; Melanie Pinto, who was nominated by Mr. Kounovsky and seconded; Nathan Copeland, who was nominated by Mr. Foster and seconded; Lily Frey, who was nominated by Ms. McRaven and seconded; Caleb Greydanus, who was nominated by Mr. Wig and seconded; Henry Elder, who was nominated by Mr. Riley and seconded; and Josh Skov, who was nominated by Mr. Pruce-Zimmerman and seconded.

The Subcommittee for PCPs reported the names of previous nominees requesting to be appointed to the position of Precinct Committee Person: George Neally, James Barber, Jason Ormsby, Leah Fisher, and Carol Sherer were appointed.

The PR Committee reported that button sales have been very successful.

The SCC Delegation reported that the SCC meeting will be held on August 20 and 21 in Eugene. Volunteers are needed for the SCC meeting and the Sate Fair booth.

The 4th CD Delegation reported that the District Nominating Convention was successful.

As New Business, the committee discussed endorsement in the Ward One City Council race.

Mr. Morris moved to consider endorsements at the July Central Committee Meeting. The motion was seconded by Mr. Pruce-Zimmerman and passed.

Upon unanimous consent, the Chair adjourned the meeting at thirty three minutes past eight o'clock.
