Central Committee Minutes

1/18/2017 - Eugene Garden Club, 1645 High St

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the Eugene Garden Club, on Thursday evening, January 18, 2018, was called to order at seven pm, Mr. Wig being in the Chair and noting a quorum, and Ms. Swenson Harris present as Secretary.

The agenda was adopted as amended.

The minutes were approved as presented.

The Treasurer's Report was received. The Party had \$5,512.36 in income and \$6,746.65 in expenses during the previous month, with a net loss of \$1,234.29.

The Budget Committee reported that the Party had \$85,141.83 in income for the year and \$49,877.08 in expenses, with a net gain of \$35,264.75. The General Fund balance is \$92,711.90.

The Chair presented the proposed 2018 DPLC Budget. Mr. Kounovsky moved to adopt the budget. The motion was seconded by Rep. Barnhart and passed unanimously.

The Campaign Services Committee reported on the upcoming January 23 special election. The Chair reported on the Party's Endorsement Meeting to be held on Wednesday, March 7.

The Community Action Chair reported that the Party will have tables at the Women's March and the Eugene Asian Celebration.

The Fundraising Committee reported that the Party's Roosevelt Dinner was successful. The Party's pancake breakfast will be held on March 3.

The Organization Committee reported that House District Chairs have been coordinating Precinct Committee People

to canvass and phonebank for Measure 101.

The Platform Committee reported on the Party's 2018 Platform Convention. Mr. Swanson presented the 2018 Party Platform. Mr. Wilde moved to approve the Platform. The motion was seconded by Ms. DeLoretto-Chudy and passed.

The Committee Considered Resolution 2018.1, Relating to Affordable Health Care for All Oregon Residents. Mr. Wilde moved to adopt the Resolution. The motion was seconded and the Resolution and passed unanimously.

The PR Committee reported on upcoming Party and community events.

The SCC Committee reported that the fourth quarter SCC meeting was held in December. The State Platform Convention will be held on March 15, 16, and 17 in conjunction with the first quarter SCC meeting. The Chair reported that the DPLC has applied to host the August SCC meeting.

The 4th CD Delegation reported that the next 4th CD meeting will be held on February 17 in Roseburg.

The Select Committee on Racial Justice reported on efforts to counteract incidents reflecting lack of cultural competency in local schools.

As New Business, the Committee considered proposed by laws amendments. Mr. Barber moved to consider amendments to Section C, Subsection 1, Subsection a. and b. separately. The motion was seconded by Mr. Swanson and failed. Ms. Reilly moved to strike "and endorsed non-partisan"

candidates" from Section F, Subsection 2. The motion was approved unanimously. Mr. Keatting moved to call the question. The motion was seconded by Mr. Kounovsky and passed. The amendments were passed.

Mr. Keating moved to declare March 3 Phil Barhart day. The motion was seconded by Mr. Carrasco and passed unanimously.

Upon unanimous consent, the Chair adjourned the meeting at ten minutes past nine o'clock.
