

DEMOCRATIC PARTY OF LANE COUNTY

Central Committee Minutes

6/21/2018 – Eugene Garden Club, 1645 High St

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the Eugene Garden Club, on Thursday evening, June 21, 2018, was called to order at fifty three minutes past seven pm, Mr. Wig being in the Chair and noting a quorum, and Ms. Swenson Harris present as Secretary.

The agenda was adopted as amended.

The minutes were approved as presented.

The Treasurer's Report was received. The Party had \$3,438.32 in income and \$10,908.16 in expenses during the previous month, with a net loss of \$7,469.84. The Party's general fund has a balance of \$63,556.70. The Party had \$25,579.83 in income for the year and \$47,507.44 in expenses, with a net loss of \$21,927.61.

The Subcommittee for PCPs reported the names of people requesting nomination for the position of Precinct Committee

Mr. Foster reported on statewide ballot measures that will appear on the November ballot.

As New Business, the Committee considered Resolution 2018.7 - Relating to the Juliana v. U.S. Trial and the Science-based National Climate Recovery Plan that the Youth Plaintiffs Seek. Ms. Sobotka moved to amend the resolution to insert "and that the Climate Recovery Plan must incorporate responses to the fact that climate change will continue to have disproportionate effects on communities of color" after the last sentence of Section 2 of the Resolution. The motion was seconded by Ms. Fragala and passed unanimously. Ms.

Sobotka moved to amend the resolution to insert "Whereas, the DPLC recognizes that global climate change will continue to have disproportionate impacts on communities of color" after the 8th Whereas of the Resolution . The motion was seconded by Mr. Thompson and passed unanimously. Mr. Rempel moved to amend the resolution to move the 16th Whereas to the start of the Resolution. The motion was seconded by Mr. Morris and passed. The resolution was adopted unanimously.

The Committee considered Resolution 2018.8- Relating to . Ms. Sobotka moved that the Party adopt Resolution 2018.8, the motion was seconded by Mr. Swanson. Ms. Kwiatkowski moved to insert "Including but not limited to mental health services, etc." The motion was seconded by Ms. Sobotka and passed unanimously. Mr. Shivers moved to call the question. The motion was seconded by Ms. Fragala and passed. Resolution 2018.8 was passed unanimously.

Ms. Beyerly reported on Marty Wilde's campaign for State Representative in House District 11.

Upon unanimous consent, the Chair adjourned the meeting at four minutes past nine o'clock.
