Central Committee Minutes

7/19/2018 – Eugene Garden Club, 1645 High St

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the Eugene Garden Club, on Thursday evening, July 19, 2018, was called to order at thirty three minutes past seven pm, Ms. Gillpatrick being in the Chair and noting a quorum, and Ms. Swenson Harris present as Secretary.

The agenda was adopted as amended.

The minutes were approved as presented.

The Treasurer's Report was received. The Party had \$10,071.89 in income and \$5,724.81 in expenses during the previous month, with a net gain of \$4,724.81. The Party's general fund has a balance of \$66,667.18. The Party had \$34,620.72 in income for the year and \$52,854.52 in expenses, with a net loss of \$18,233.80.

The Campaign Services Committee reported on the upcoming November election and encouraged PCPs to volunteer. The Community Action Committee reported that the DPLC Summer Civics Fest will be held on Saturday, July 28. The Party will have a booth a parade entry in the Sunday Streets Celebration and will be hosting a second yearly yard sale.

The Fundraising Committee reported that a fundraising mailer will be sent out on Friday. The mailing will include invitations to the Summer Civics Fest and the DPLC Chili Cook Off, which will be held on August 26.

Mr. Wold reported on the Party's voter registration efforts.

The Organization Committee reported on House District parties. Mr. Shivers reported that House District 8 will hold a house party on July 22nd. Mr. Thompson reported that the Florence Democrats have opened an office for the general election.

The Subcommittee for PCPs reported the names of previous nominees requesting to be appointed to the position of Precinct Committee Person: Susan Bowman, Ethan Clevenger, and Lil Frey were appointed.

The Platform Committee reported that the top legislative action item for the Democratic Party of Oregon is health care.

The P.R. Committee reported that the Chili Cook Off will be held on August 26 and that the Committee is working to organize the Springfield Spaghetti Slam in September.

The Rules Committee Reported that a meeting will be held in September.

The Chair reported that the Third Quarter State Central Committee Meeting will be held at Lane Community College on August 11 and 12.

The 4th Congressional District Committee reported that the 4th CD met in Coos Bay on July 15.

As New Business, the Committee considered Endorsement of the Springfield Street Bond. The Platform Committee ad-

vanced a recommendation to endorse the bond. The Springfield Street Bond was endorsed unanimously.

The Committee considered Resolution 2018.9 - Relating to POEM (Post Office to Eugene Museum. The Platform Committee advanced the Resolution and it was adopted unanimously.
