Endorsement Meeting Minutes

3/7/2018 – University of Oregon McKenzie Hall, Room 190

The Endorsements meeting of the Democratic Party of Lane County Central Committee, held at McKenzie Hall, on Wednesday evening, March 7 2018, was called to order at one minute past seven pm, Mr. Wig being in the Chair and noting a quorum, and Ms. Swenson Harris present as Secretary.

The agenda was adopted as presented.

The Committee considered endorsement of two candidates for the Eugene Water and Electric Board at Large Position: Mindy Schlossberg and Zach Mulholland. Mr. Swanson moved to vote on endorsement all candidates in the race. The motion was seconded by Ms. Kennedy and passed unanimously. Mr. Keating moved to endorse the candidates by acclimation. The motion was seconded by Ms. Camblin and passed. Mr. Matthews moved to endorse all candidates by acclimation. The motion was seconded by Mr. Pinger and passed. Both candidates were endorsed unanimously.

The Committee considered the endorsement of Christopher Dean for Eugene City Council, Ward 5. Mr. Pinger moved to suspend Standing Rule A for the consideration of endorsements in the Ward 5 City Council race. The motion was seconded by Ms. Camblin and passed. Ms. Gervase moved to endorse Christopher Dean, the motion was seconded by Mr. Pinger and passed unanimously.

The Committee considered the endorsement of Greg Evans for Eugene City Council, Ward 6. Mr. Pruce-Zimmerman moved to endorse Greg Evans, the motion was seconded by Ms. Hibler and passed.

The Committee considered the endorsement of Nora Kent for Lane County Commissioner, West Lane. Mr. Carrasco moved to endorse Nora Kent, the motion was seconded by Mr. Keating and passed.

The Committee considered the endorsement of Joe Berney for Lane County Commissioner, Springfield. Ms. Jennings moved to endorse Joe Berney, the motion was seconded by Mr. Keating and passed.

The Committee considered endorsement of four candidates for Lane County Commissioner: Heather Buch, James Barber, Kevin Matthews, and Tim Laue. Mr. Rempel moved to endorse all candidates in the race. The motion was seconded by Ms. Jennings and passed. Ms. Kennedy moved to endorse the candidates by acclamation. The motion was seconded by Mr. Reilly and passed. All four candidates were endorsed.

The Committee considered the endorsement of the Eugene Parks Levy. Mr. Ricketts moved to endorse the levy. The motion was seconded by Ms. Demler. Mr. Keating moved to vote on the endorsement by acclamation. The motion was seconded by Mr. Shivers and passed. The levy was endorsed.

The Committee considered the endorsement of the Eugene Parks Bond. Mr. Wilde moved to endorse the bond. The motion was seconded by Mr. Morris and passed. Mr. Keating moved to vote on the endorsement by acclamation. The motion was seconded by Mr. Shivers and passed. The bond was endorsed.

The Committee considered the proposed rules for consideration of

auditor measures. Mr. Rempel moved to adopt the proposed rules. The motion was seconded by Mr. Thompson and passed. Neither measure was endorsed.
