Central Committee Minutes

3/21/2019 – Eugene Garden Club, 1645 High St

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the Eugene Garden Club, on Thursday evening, February 21, 2018, was called to order at one minute past six pm, Mr. Wig being in the Chair and noting a quorum, and Ms. Swenson Harris present as Secretary.

The agenda was adopted as amended

The minutes were approved as presented.

The Treasurer's Report was received. The Party had \$3,810.58 in income and \$2,859.08 in expenses during the previous month, with a net loss of \$951.50. The Party's general fund has a balance of \$62,969.87.

The Budget Committee reported that the budget is on track with \$9,628.78 in income for the year and \$12,408.23 in expenses, with a net loss of \$2,779.45.

The Subcommittee for PCPs reported the names of people requesting nomination for the position of Precinct Committee Person: Colin Lyons, nominated by Mr. Kounovsky; and Joel Iboa, nominated by Mr. Wig.

The Subcommittee for PCPs reported the names of previous nominees requesting to be appointed to the position of Precinct Committee Person: Katie Rodriguez, Angela VanKrause, Emma Empol, and Stephen Bryan were appointed.

Mr. Cronin moved to suspend the rules to allow proponents of Measure 20-299 to speak in favor of an endorsement for 10 minutes. The motion was seconded by Mr. Thompson and passed.

The Platform Committee advanced a recommendation of an endorsement in favor of Measure 20-299. The Measure was endorsed unanimously.
