Central Committee Minutes

9/19/2019 - Eugene Garden Club, 1645 High St

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the Eugene Garden Club, on Thursday evening, September 19, 2018, was called to order at fifty eight minutes past six pm, Ms. Gillpatrick being in the Chair and noting a quorum and Ms. Swenson Harris present as Secretary.

The agenda was adopted as presented.

Mr. Cronin moved to postpone the minutes to the October meeting. The motion was seconded by Mr. Koivula and passed unanimously.

The Treasurer's Report was received. The Party had \$7,766.52 in income and \$6,221.00 in expenses during the previous month, with a net gain of \$1,545.52. The Party's general fund has a balance of \$63,685.03.

The Budget Committee reported that the budget is on track with \$47,980.96 in

income for the year and \$50,046.47 in expenses, with a net loss of \$2,065.51.

Ms. Swenson Harris provided a report on services available to candidates running in the May 2020 election. Letters will be sent to candidates as they file. Brian Josephson has appointed Campaign Services Vice Chair.

The Community Action Committee reported that the Party will be participating in the Eugene Celebration Parade. Erin Barnhart has been appointed Community Action Vice Chair.

The Fundraising Committee reported on organizing efforts for the Roosevelt Dinner. The Dinner will be held on November 8 at the Downtown Athletic Club.

The Organization Committee reported that the PCP Training on August 15 was successful.

The State Central Committee Delegation reported that the fourth Quarter SCC Meeting will be held in November.

The 4th Congressional District Delegation reported that the 4th CD meeting will be held on September 29 in Linn County.

As New Business, The Committee held elections for alternates to the State Central Committee. Lisa Levsen, Amy Unfred, Rebecca Bradvica, and Richard Cundiff were elected.

As New Business, The Committee held elections for alternates to the 4th Congressional District Committee. Karin Radtke and Rebecca Bradvica were elected.
