Central Committee Minutes

4/21/2022 – Eugene Garden Club

The monthly meeting of the Democratic Party of Lane County Central Committee, held at the Eugene Garden Club, on Thursday evening, April 21, 2022 was called to order at thirty five minutes past six pm, Mr. Wig being in the Chair and noting a quorum and Ms. Swenson Harris present as Secretary.

The agenda was adopted as amended.

The Organization Committee reported on upcoming House District Meetings and Organizing.

House District 13 reported on Neighborhood Leader Organizing and coordination with campaigns.

House District 14 reported on neighborhood Leader trainings.

Ms. Gillpartick provided a report on the Neighborhood Leader Program.

Ms. Heermance provided a report on the upcoming PCP election. Those who

have not filed for reelection can be elected with three write in votes and must file a write in declaration to have their votes counted.

The minutes were approved as presented.

The Treasurer's report was received. The Party had \$37,752.60 in income and \$18,016.69 in expenses for the month, for a net gain of \$19,735.91.

The Budget Committee report was received. The Party had \$49,490.60 in income and \$29,716.99 in expenses for the year to date, for a net gain of \$19,773.61.

The Campaign Services Committee reported on working with candidates in the May election. Ms. LeGate provided a report on Field Organizing for the May election. Mr. Cronin moved to authorize up to \$25,000 in campaign expenses for the May primary and authorize the Executive

Committee to make additional expenditures up to \$10,000. The motion was seconded by Mr. Josephson and passed.

The Community Action Committee reported on the Party's booths at community events. The Party will have a booth May 26 and 27 at the Florence Rhododendron Festival and the Lane County Fair. Ms. Bradvica reported on the Party's Community Service Activities.

The Fundraising Committee reported on the Roosevelt Gala. The Gala was successful, with \$66,877 in gross income.

The PR Committee reported on publicity for campaign events.

The Platform Committee reported that the Party has sent a letter to Senator Wyden in support of health insurance subsidy expansion.

The State Central Committee Delegation reported that the State Central Committee will meet on March 26 and 27 in Roseburg. The SCC will meet on June 11 and 12.

The 4th Congressional District Committee Delegation reported that the CD held a forum for congressional candidates in the CD 4 Primary.

The Office Committee reported that the Party's office is open.

As New Business, the Committee Considered Resolution 2022.2 - Regarding the Eugene Planning Commission's Unanimous Middle Housing Code Recommendation. Mr. Cronin moved to allow for a question and answer period following the presentation of the Resolution and to limit debate to 30 minutes after the question and answer period. The motion passed by unanimous consent. The Resolution was adopted unanimously.

Upon unanimous consent, the Chair adjourned the meeting at twelve minutes past eight o'clock.
